1. Background and Narrative of Budget Reductions:

In 2011, the Valmeyer CUSD #3's Board of Education went to the voters of the district to ask for a temporary tax increase (working cash bonds). The stated goal of the referendum was to keep the district from having to cut expenses/programs. The Voters passed the WC Bond Issuance by a 3-1 margin. For the past five years, the district has used those proceeds to supplement the operating funds through an annual abatement of WC Funds.

The original five year plan was extended by the voters in March of 2016 via another successful WC Bond referendum that again passed by a 3-1 margin.

2. Assumptions Used in the Deficit Reduction Plan:

It is the Board's intention to sell WC bonds in the Spring of 2018.

We will then continue to use WC to supplement our Operating Fund Accounts for the next five years (2018-2022). The proc
